The course conforms with the Practice Management Course Guidelines for New South Wales published by The Law Society of New South Wales and has been designed for legal practitioners, that have at least two years of supervision. The course is not limited to any particular type of practitioner. The flexible delivery of the course equips legal practitioners with future-focused content in a format that is accessible for busy practitioners.

PMC Plus is designed to take a learner approximately 30 hours. The course is made up of three modules with components: online modules (19.5 hours), three webinars (3 hours) and a one-day face to face intensive (7.5 hours).
